

UMREICH'S ANGELPARADIES OSLIP GENERAL OPERATING REGULATIONS

These regulations are for the protection of the water body and the preservation of a diverse fish population. Compliance should therefore be in the best interest of each angler. By accepting these regulations, the obligation to acknowledge and adhere to them is assumed. We also welcome visitors with dogs but would like to point out that dogs must be kept on a leash on the premises. For "list dogs" and aggressive dogs, a muzzle is additionally required. By purchasing a fishing permit (day or annual ticket), you also become an extraordinary member of the "Sportverein Angelparadies Oslip" for the duration of its validity.

GENERAL PROVISIONS:

- § 1: The fishing permit must always be carried and shown to the supervising persons upon request. The Burgenland fishing card is mandatory and must be presented when purchasing the day or annual ticket. Every ticket holder is required to acknowledge and comply with the valid operating regulations. This also applies to day ticket holders the additional conditions are listed on the day ticket. The lease boundaries and areas where fishing is permitted are shown on a map on the bulletin board. Access by car to the fishing spots is not possible.
- § 2: Fishing with two rods is permitted, with the fishing line on one rod allowed to have only a single hook (except for predator fishing). Only Micro Barbed hooks in sizes 4-8 are allowed. For bottom fishing, casting weights up to 60 grams are permitted. Fishing for carp with braided line is prohibited. The use of a landing mat is mandatory. In addition to the methods prohibited by law, fishing with nets and traps is also prohibited.
- § 3: Chumming with boilies, pellets, grain feed, and wet feed (max. 1.5 kg per day until further notice) is allowed.
- § 4: If an angler intends to release an uninjured fish, it must be done immediately and with the utmost care. Fish in the keepnet are considered caught and may not be released or exchanged. Undersized and uninjured fish caught during closed seasons must be released immediately with the utmost care. Injured fish must not be released and should be reported immediately to the clubhouse.
- § 5: Closed Seasons and Minimum Sizes
 - Tench and Crucian Carp: May 1 May 31, 25 cm
 - Pike: February 1 April 30, 50 cm
 - Zander and Bream: April 1 May 31, 35/25 cm
 - Catfish: May 15 June 15, 60 cm
 - Carp: May 15 June 30, 35 cm

Special Regulations:

- All small white fish species (e.g., minnows, bitterling, stickleback), mudfish, all crayfish, all mollusks, and koi carp are protected year-round.
- Carp over 60 cm (or 4 kg) and catfish over 20 kg must be released!
- § 6: Every angler is required to assist in the monitoring of the water body and to report any observed violations of legal regulations or operating rules, especially any water contamination or changes in the fish population to the management or the designated supervising persons.
- § 7: The fee for the fishing permit is non-refundable, regardless of whether the angler uses it or not, or if the fishing rights are revoked. There is also no refund for temporary operational

closures of the entire facility (maximum of 5 days per year). Any closures will be announced on the internet and the bulletin board.

- § 8: The role of the control authorities is to monitor compliance with the operating regulations. Their instructions and requests must be followed without exception.
- § 9: We ask for peace and cleanliness at the fishpond. Many fellow anglers visit the water not only for fishing but also for relaxation and out of love for nature. In the interest of sensible nature and species conservation, we request the utmost consideration for the existing animal and plant species. The handling of open fire is strictly prohibited throughout the entire area. The only exception is the barbecue area in front of the hall, for which prior approval must be obtained.

Any waste must be properly disposed of in the trash container near the hall.

§ 10: Any violation of the operating regulations entitles the management or the designated supervising persons to immediately revoke the fishing rights of the angler in question.

SPECIAL REGULATIONS FOR ANNUAL TICKET HOLDERS

- 1. Every annual ticket holder is obligated to acknowledge and comply with the general operating regulations.
- 2. The fishing hours for annual ticket holders are from October to March, starting at sunrise and ending at 6:00 PM. From April to September, fishing is allowed between sunrise and 8:00 PM. Fishing is only permitted when the facility is completely ice-free. From early May to the end of September, night fishing is allowed on Thursday to Friday, Friday to Saturday, and Saturday to Sunday nights, as well as on the nights before public holidays, starting at 8:00 PM (after prior registration at the clubhouse or by phone at 0676464672254). Night fishing ends at 7:00 AM, and the angler must report leaving the pond at the clubhouse. Current information for night anglers who wish to set up a tent can be found on the bulletin board at the gate this notice is also part of the operating regulations. For those with an annual ticket for sport fishing, predator fishing and night fishing are not permitted.
- 3. For annual ticket holders with fish extraction, 10 carp (up to 4 kg or 60 cm), 5 predator fish (catfish up to 20 kg, zander, or pike) are available for catch. A maximum of 2 trophy fish may be taken per day, and held fish count as caught. All taken or held fish must be immediately recorded in the annual ticket with the date, fish species, and size. Spinning is only allowed from September to the end of January. Worms as bait are permitted; live baitfish are prohibited. Dead baitfish are allowed but must be caught on-site or purchased at the clubhouse to prevent the introduction of diseases from fish from foreign waters.
- 4. Holders of an annual ticket have the option to purchase an additional ticket for children up to 13 years old or a partner at the price of €80 (allowing them to fish with an additional rod in the presence of the annual ticket holder). For annual tickets with fish extraction, taken fish must be recorded in the main ticket holder's card. It is not allowed to have other people fish on behalf of the ticket holder. This rule does not apply to partners and children up to 13 years without an additional rod and in the presence of the annual ticket holder.

The Management
