



UMREICH'S FISHING PARADISE OSLIP GENERAL OPERATING REGULATIONS

These operating regulations serve to protect the waters and preserve a diverse fish population. Compliance is therefore in the interest of every angler. By accepting these regulations, each angler agrees to acknowledge and follow them. We also welcome visitors with dogs – however, please note that leashes are required throughout the premises. For “listed dogs” and aggressive dogs, a muzzle is additionally required.

With the purchase of a fishing permit (day or annual pass), the holder becomes an extraordinary member of the association “*Sportverein Angelparadies Oslip*” for the validity period of the permit.

GENERAL PROVISIONS

§ 1:

The fishing permit must always be carried and shown upon request to authorized supervisory personnel. The Burgenland State Fishing Card is mandatory and must be presented when purchasing a day or annual pass. Each cardholder is obligated to acknowledge and comply with these operating regulations. This applies especially to holders of day passes – additional conditions are listed on the day pass.

Lease boundaries and areas where fishing is permitted are shown on the map on the notice board. Access to fishing spots by car is not possible.

§ 2:

Fishing is permitted with two rods, whereby the line of one rod may only be equipped with a single hook (except when fishing for predatory fish). When bottom fishing, casting weights are limited to 60 grams.

Fishing for carp with braided main line is prohibited. For carp rods, the following rules apply:

- Safety clip up to the swivel of the main line (minimum 0.30 mm)
- Standard coated leaders
- Hook size 4–6, only micro-barbed hooks permitted

For feeder rods and match rods, a monofilament leader is required.

Every angler must carry fish-care equipment to treat injuries.

Using an unhooking mat is mandatory.

In addition to legally prohibited fishing methods, the use of nets or traps is also forbidden.

§ 3:

Groundbaiting is allowed with boilies, pellets, grain feed, and wet feed (maximum total 1.5 kg/day until further notice).

§ 4:

If an angler intends not to keep undamaged fish, they must be released immediately with the greatest possible care.

Any fish held in a keepnet is considered kept and may not be released or exchanged.

Undersized or undamaged fish caught during closed seasons must be released immediately with utmost care.

Injured fish must not be released and must be reported immediately to the clubhouse.

§ 5: Closed Seasons and Minimum Sizes

Species	Closed Season	Minimum Size
Tench & Crucian Carp	May 1 – May 31	25 cm
Pike	Feb 1 – Apr 30	50 cm
Zander & Bream	Apr 1 – May 31	35/25 cm
Catfish	May 15 – Jun 15	60 cm
Carp	May 15 – Jun 30	35 cm

Special rules:

Protected year-round: all small whitefish species (e.g. moderlieschen, bitterling, stickleback), weatherfish, all crayfish, all mussels, and colored carp (koi).

Carp over 60 cm (or 4 kg) and catfish over 20 kg must be released!

§ 6:

Every angler is obliged to help monitor the waters and report any violations of legal regulations or these rules, especially any water pollution or noticeable changes in fish populations, to the management or authorized supervisors.

§ 7:

The fee paid for a fishing permit will not be refunded in cases of non-use or revocation of the permit. There is also no refund for operational closures of the facility (maximum 5 days per year). Any closures will be announced online and on the notice board.

§ 8:

The task of the control officers is to ensure compliance with the operating regulations. Their instructions must be followed without exception.

§ 9:

Please maintain silence and cleanliness at the fishing lake. Many anglers come not only to fish, but also to relax and enjoy nature. In the interest of environmental and species protection, please show maximum consideration for local plant and animal life.

Open fire is strictly prohibited throughout the premises.

Exception: the barbecue area in front of the hall – its use must be approved in advance.

All waste must be disposed of properly in the waste containers near the hall.

§ 10:

Any violation of the operating regulations entitles management or supervisory staff to immediately revoke the angler's fishing permit.

SPECIAL PROVISIONS FOR ANNUAL PERMIT HOLDERS

1. Every annual permit holder must acknowledge and comply with the general operating regulations.
2. Daily fishing time for annual permit holders runs from sunrise to sunset (January–December). Fishing is only permitted when the facility is completely free of ice.
From early May to late September, holders of an annual permit *with* fish-take option may fish at night on the following days:
 - Thursday → Friday
 - Friday → Saturday
 - Saturday → Sunday
 - nights before public holidays

Night fishing begins at 20:00 (after prior registration at the clubhouse or by phone: 0664 75207762) and ends at 07:00. Leaving the lake must be reported at the clubhouse.

Current information for night anglers wishing to set up a tent is posted on the notice board at the gate – this notice is also part of the operating regulations.

With a *Sport* annual pass, fishing for predatory fish and night fishing are not permitted.

3. Annual permit holders with fish-take authorization may keep:
 - **10 carp** (up to 4 kg or up to 60 cm),
 - **5 predatory fish** (catfish up to 20 kg, zander, or pike).

A maximum of 2 noble fish may be taken per day; fish held in a keepnet count as taken.

All kept or keepnet-held fish must be recorded immediately in the annual pass with date, species, and size.

Spinning is allowed only from September to the end of January.

Worms are allowed; live baitfish are prohibited.

Dead baitfish are allowed but must either be caught on-site or purchased from the clubhouse to prevent disease introduction.

4. Annual permit holders may purchase an additional pass for children up to 13 years or partners for €80 (fishing with one additional rod is allowed when accompanied by the annual pass holder).
For annual passes with fish-take rights, all caught fish must be entered in the primary cardholder's pass.
It is prohibited to let other persons fish on your behalf.
This does not apply to partners or children up to 13 years without an additional rod and only when accompanied by the annual pass holder.
